Internal Market Results Announcement

The Internal Market held on 24 September 2018 has now been completed.

PricewaterhouseCoopers (PwC), the Internal Market Administrator, has advised the ESOP Trustee that the weighted average successful bid price was €1.09 per share (the Market Price) and this is the price that will be paid to all successful sellers.

Please note that all forced sale shares were sold. Participants who offered shares for voluntary sale at minimum prices equal to or below the market price have been partially successful and sold approximately 28% of the shares offered.

PwC will be writing to all participants who submitted market forms. Payments to successful sellers will be issued on 8 October 2018.

The ESOP Trustee will be writing to all participants in due course.
