### **Internal Market Results Announcement**

The Internal Market held on 22 September 2017 has now been completed.

PricewaterhouseCoopers (PwC), the Internal Market Administrator, has advised the ESOP Trustee that the weighted average successful bid price was €1.17 per share (the Market Price) and this is the price that will be paid to all successful sellers.

Please note that all forced sale shares were sold. Participants who offered shares for voluntary sale at minimum prices equal to or below the market price have been partially successful and sold approximately 7% of the shares offered.

PwC will be writing to all successful and partially successful sellers and all bidders. Payments to successful sellers will be issued on 6 October 2017.

The ESOP Trustee will be writing to all participants in due course.
